We have heard repeatedly that the community are extremely excited as this building will be used for secondary school students. It has been wonderful to see a new building go up in the midst of so much chaos in other areas Haiti.

SORT OF GOOD NEWS

Claire Heureuse Hospital continues to see patients 24/7 despite the ongoing difficulties of finding medical supplies and a significant decrease in income from patient receipts as people are less able to pay as a result of the economic downturn and severe inflation. (31% inflation) Unfortunately it has been a number of months since the employees have been paid. This has been difficult for all to hear about and obviously very serious for the employees HHA continues to send quarterly support.

MORE GOOD NEWS

In Vialet, the Susanna Wesley clinic has been started using designated funds. Nortrius continues to oversee the building project which has been contracted to a local Haitian building engineer.

This building project has been a number of years in planning.

Despite all of the difficulties, Pastor remains upbeat and confident that God is in charge. His faith is firm.

The town of Vialet, located in south Haiti, remains calm and to date has been free from any gang activity.

Traffic and business as usual continue from Leogan, the 1st town after you leave Port-au-Prince

driving south, all the way to the southern tip of Haiti. Supplies, including building materials, are also available as there are 2 shipping ports open from which most goods enter. Pastor Nortrius believes the gangs have left the southern areas of Haiti alone as when they attempted to enter the first towns heading south, there was tremendous resistance from the local populations causing the gangs to pull out.



VIALET CLINIC FOUNDATION

We want to thank all for the continued thoughts, prayers and financial support. In 2025 HHA will has sent \$18,000 to the hospital for support, \$1400 to the Susanna Wesley clinic, Vialet, for operations and \$15,000 for the clinic building construction. These funds represent your support in 2025.

Bishop Desvariste has also returned to Haiti and has sent some videos of the Pac Chretienne church at Delmas 28. The church has been looted and virtually stripped of its windows and roofing and the floors have been damaged. It will be a major rebuild however the congregation are united in their desire to meet once again in their church. HHA continues to send the church in Haiti funds as we have them available.
